

This letter shall constitute your final notice by the Finade Island Board of Examiners of Landscape — Architects that your application for a certificate of authorization (COA) which was previously filed within the registration period 1 July 2004 - 30 June 2006 has NOT been granted by this Board. The reason for the failure to issue this certificate of au horization is that you have failed to complete the application process by not submitting to this office your <u>CERTIFICATE OF GOOD STANDING</u>. You should receive this document from the RI Secretary of State's Office.

Because you do not hold a certificate of authorization to practice landscape architecture within the State of Rhode Island, please be advised that in the event that this Board should determine that you have practiced or offered to practice landscape architecture within this State, the Board will view this as a willful and intentional violation of Rhode Island law and will take action accordingly. Such actions by this Board may include the referral to the Altorney General's Office for criminal prosecution in accordance with Title 5, Chapter 51, of the Rhode Is and General Laws.

In the event that you wish to pursue your application for a certificate of authorization, you must complete the application process as directed within thirty (30) days of the date of this letter.

If Certificate of Good Standing is not received within this final 30-day period, the Board will not take any further action on your application, and on that deadline date, you must <u>CERSE</u> and <u>dealst</u> from practicing or offering to practice landscape architecture in the State of Rhode laland per the <u>GENERAL LAWS C F RHODE ISLAND \$ 5-51-13</u>. Failure to submit the Good Standing will result in the denial and termination of the application process by this Board.

If you have any questions regarding obtaining your Certificate of Good Standing please feel free to contact the Secretary of State's office at 401-222-3040 and ask for Corporations. Please keep in mind that unless we receive the Certificate of Good Standing to complete your application for COA within thirty (30) days of the date of this letter, your application will be terminated without further notice to you.
