Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Ritchie Allon Morse Scholarship Fund

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF THE FUND SHALL BE TO PROVIDE FINANCIAL ASSISTANCE TO TWO(2) HIGH SCHOOL SENIORS WHO PREVIOUSLY PLAYED THREE (3) YEARS OF POP WARNER FOOTBALL OR CHEERLEADING FOR THE NORTH KINGSTOWN JAGUARS ORGANIZATION AND WHO DESIRE TO FURTHER THEIR EDUCATION AFTER HIGH SCHOOL.

THE FUND WILL BE SOLELY USED FOR THE RECIPIENTS COLLEGE EDUCATION EXPENSES. THE CRITERIA BY WHICH STUDENTS WILL BE JUDGED ARE: ESSAY, SCHOLARSHIP, EXTRA CURRICULAR AND COMMUNITY ACTIVITIES.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE BUSINESS OF THE FUND SHALL BE CARRIED OUT THROUGH THE RITCHIE ALLON MORSE SCHOLARSHIP COMMITTEE-(HEREINAFTER REFERRED TO AS THE COMMITTEE).

THE COMMITTEE SHALL BE COMPRISED OF PERSONS COMMITTED TO FURTHERING THE PURPOSE OF THE FUND. MEMBERSHIP ON THE COMMITTEE SHALL BE AT THE INVITATION OF A MEMBER OF THE MORSE FAMILY.
