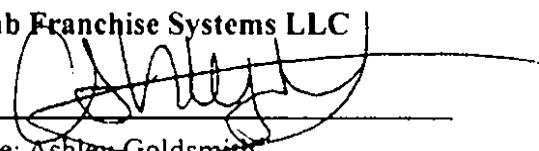
Limited Power of Attorney

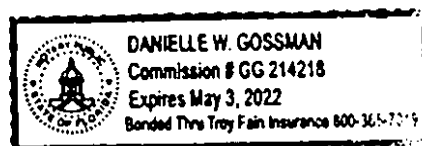
