

IT IS THEREFORE ORDERED THAT:

- 1. The Motion is granted.
- 2. Pursuant to Rules 2002(i), 2002(m), 4001, 6004, 6006, 6007, 9006, 9007, 9013, 9014, and 9019 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), notice of the Limited Notice Matters (as defined below) is limited to (a) the Office of the United States Trustee, (b) counsel for any official creditors' committee appointed in this case, or, if no creditors' committee is appointed, the 20 largest unsecured creditors, (c) the mortgage line lenders, (d) parties that file with the Court and serve upon the Debtors requests for notice of all matters in accordance with Bankruptcy Rule 2002, and (e) any party with a pecuniary interest in the subject matter of the particular Limited Notice Matter (as defined below) or its counsel (the "Limited Service List").
- Service of motions or applications regarding the following matters or proceedings 3. (collectively, the "Limited Notice Matters") is limited to the Limited Service List:
 - any proposed use, sale, or lease of property of the estates pursuant to section a. 363 of the Bankruptcy Code and Bankruptcy Rules 2002(a)(2), 4001(b), and 6004 (except a sale of substantially all assets of the Debtors); :
 - any proposed extension of the Debtors' exclusive time to file plans of b. reorganization and solicit acceptance thereof (including, without limitation, the time to file disclosure statements) pursuant to section 1121 of the Bankruptcy Code and Bankruptcy 9 Rule 3016;
 - any proposed approval of a compromise or settlement of a controversy c. pursuant to section 363 of the Bankruptcy Code and Bankruptcy Rules 2002(a)(3) and 9019;
 - any proposed abandonment or disposition of property of the estates pursuant d. to section 554 of the Bankruptcy Code and Bankruptcy Rules 6007(a) or (c);
 - any proposed assumption or rejection of contracts or leases under section 365 e. of the Bankruptcy Code and Bankruptcy Rule 6006;
 - any proposed application for compensation or reimbursement of expenses of f. professionals, pursuant to sections 328, 329, 330, or 331 of the Bankruptcy Code and Bankruptcy Rules 2002(a)(6), 2016, 2017, and 6005; and

- a hearing on any contested matter in this case that requires notice to all g. creditors or equity holders pursuant to the Bankruptcy Code, Bankruptcy Rule 9014, or the Local Bankruptcy Rules.
- Notwithstanding anything to the contrary herein, this Order does not affect the rights 4. of all creditors in this case to receive notice of the following matters or proceedings: (a) a hearing on the dismissal or conversion of these cases; (b) the time fixed for filing objections to a disclosure statement and the hearing to consider approval of any disclosure statement; (c) the time fixed for accepting, rejecting, or objecting to confirmation of any plan or any modification thereof and the hearing thereon; (d) the entry of an order confirming a plan; and (e) the date fixed for filing proofs of claim.
- Pursuant to Bankruptcy Rule 7004(h)(2), the Debtors are authorized to serve insured 5. depository institutions by first class mail in all contested matters and adversary proceedings in these cases.
- 6. The Debtors shall provide a copy of the Limited Service List to any creditor or party in interest that makes a written request to the Debtors' bankruptcy counsel.
- The Debtors shall serve a notice of entry of this Order upon all parties in its mailing 7. matrix.
