

This cause came on to be heard before this Honorable Court upon the Plaintiff's Complaint to Reinstate the Charter of the corporation and file the Annual Report required by statute to be filed, and after hearing statement of counsel, it is hereby:

ORDERED

1. Plaintiff may file upon payment of the filing fee its Annual Report for the years 1984 through 1989 as attached to the Complaint and made a part hereof.

2. That the Defendant shall accept the filing upon the payment of the filing fee for said Annual Report for the years 1984 through 1989.

3. Upon filing said Annual Reports and the payment of the filing fees, the Defendant shall reinstate the Charter of the Plaintiff corporation and consider the same in good standing retroactive to the date of its forfeiture.

4. Plaintiff hereby waives any right to a hearing do novo pursuant to R.I.G.L.A. 7-1.1-33.


