It is enacted by the General Assembly as follows:

- 1 SECTION 1. If, on or before December 31, 2006 Hilco Athletic & Graphics, Inc.,
- 2 incorporated on shall file any corporation tax returns as may be required, and shall pay all taxes
- 3 which were due or should have been due to the state, and shall file with the secretary of state a
- 4 certificate signed by the tax administrator that such tax returns and such taxes have been paid; and
- 5 shall also file all reports and pay all fees which may be required by the secretary of state, then the
- 6 revocation of the charter of said corporation shall thereupon to wit, upon the filing of said
- 7 certificate, said reports and the payment of said fees, be vacated and said corporation shall
- 8 thereupon be entitled to all the privileges, benefits and powers and subject to all of the same
- 9 duties and liabilities as though no revocation of its charter had taken place.
- 10 SECTION 2. This act shall take effect upon passage.
