**TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF
TUCKERTOWN FIRE DEPARTMENT, INC.**

It is enacted by the General Assembly as follows:

- 1 SECTION 1. The time within which Tuckertown Fire Department, Inc., incorporated on
2 May 27, 1980, shall file the reports for the years 1986, 1987, 1988, 1989, 1990, 1991, 1992,
3 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007,
4 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, and 2018, as required under the
5 provisions of § 7-6-90 of the general laws of Rhode Island, 1956, is hereby extended to the 31st
6 day of December, A.D., 2018, if said corporation shall file in the office of the secretary of state
7 before December 31, 2018, the reports which it should have filed in the said years and shall pay
8 to the secretary of state the filing fees therefor, having previously thereto paid to the general
9 treasurer for the use of the state such sum as the attorney general shall decide should be paid by
10 said corporation as a compromise for the penalty or penalties for its failure to file such reports
11 then the forfeiture or revocation of the charter of said corporation shall thereupon, to wit, upon
12 the filing of said reports and the payment of said fees, be vacated and said corporation shall
13 thereupon be entitled to all of the privileges, benefits and powers and subject to the same duties
14 and liabilities as though no forfeiture or revocation of its said charter had taken place.
15 SECTION 2. This act shall take effect upon passage.

Re: Penalty Fee to Secretary of State

Dear Mr. Wieters:

The Department of Attorney General has received your request that the Department partially waive penalty fees for Tuckertown Volunteer Fire Department, Inc., a Domestic Non-Profit Corporation. The penalty accrued for failure to submit annual reports to the Secretary of States which caused a revocation of the articles of incorporation on November 30, 1986. Because it was revoked over ten (10) years ago you petitioned the General Assembly for reinstatement. As a result, the revocation was vacated effective June 13, 2018. You currently owe \$660.00 for reinstatement and a penalty fee of \$800.00.

Pursuant to R.I. Gen. Laws Section 7-1-23 the Attorney General may "compromise any penalty and permit the payment of a "smaller sum" than what has been assessed. There is, however, no provision for a complete waiver of the penalty fee.

After reviewing the documents received and confirming with the Secretary of State's office, this letter is to inform you that the Attorney General authorized a reduction of the \$800.00 penalty imposed on Tuckertown Volunteer Fire Department to \$50.00. This is contingent, however, on the filing of the missing annual reports which it should have filed in said years and paying the total fee amount of \$660.00

You must provide a copy of this letter to the Secretary of State in order to reinstate your charter. If you have any questions, please do not hesitate to contact me.
