ARTICLE 1

NAME

THIS VOLUNTEER FIRE COMPANY SHALL BE KNOWN AS JOHNSTON HOSE NO. 1 VOLUNTEER FIRE DEPARTMENT.

ARTICLE 11

PURPOSE

TO DEVELOP COOPERATION BETWEEN THE HOSE COMPANY AND THE CITIZENS OF THE TOWN.

TO ENCOURAGE SOCIAL ACTIVITIES AMONG ITS MEMBERS.

TO RENDER MUTUAL AID TO THE PERMANENT AND CALL FIREMEN WITHIN THE TOWN AND TO NEIGHBORING TOWNS AND CITIES WHEN CALLED UPON TO DO SO.

ARTICLE 111

MEMBERSHIP

SECTION 1. THE MEMBERS SHALL BE PLACED IN THREE CLASSES, NAMELY, ACTIVE. LIFE, AND HONORARY.

SECTION 2. AN APPLICANT MUST BE AT LEAST SIXTEEN (16) YEARS OF AGE AND A RESIDENT OF JCHNSTON HOSE NO. 1 DISTRICT TO BE ELIGIBLE FOR ACTIVE MEMBERSHIP.

ARTICLE 1V

OFFICERS

ADMINISTRATIVE

PRESIDENT VICE PRESIDENT SECRETARY TREASURER

ARTICLE V

MEETINGS

THERE SHALL BE FOUR REGULAR MEETINGS OF THE HCSE COMPANY HELD ON THE FIRST TUESDAY OF THE FOLLOWING MONTHS: JANUARY, APRIL, SEPTEMBER, AND NOVEMBER. THE MEETINGS SHALL BE HELD IN THE HCSE COMPANY'S HEADQUARTERS AND CALLED TO ORDER BY EIGHT O'CLOCK.

THE PRESIDENT SHALL HAVE THE POWER TO POSTPONE ANY BUSINESS MEETING FOR A PERIOD OF NOT MORE THAN TWO WEEKS.

SPECIAL MEETINGS SHALL BE CALLED BY ORDER OF THE PRESIDENT OR BY ORDER OF THE EXECUTIVE COMMITTEE THROUGH THE PRESIDENT. ANY TEN ACTIVE OR LIFE MEMBERS IN GOOD STANDING MAY REQUEST A SPECIAL MEETING. A WRITTEN PETITION MUST BE FILED WITH THE SECRETARY AT LEAST TEN DAYS BEFORE THE DATE OF THE SPECIAL MEETING.

ALL BUSINESS PRESENTED TO THE EXECUTIVE COMMITTEE MUST BE IN WRITING TO THE SECRETARY, SIGNED BY AT LEAST TEN ACTIVE OR LIFE MEMBERS OF THE HOSE COMPANY.

ARTICLE V1

AMENDMENTS

THE CONSTITUTION AND BY-LAWS OF THIS HOSE COMPANY SHALL BE AMENDED BY AT LEAST A TWO-THIRDS VOTE OF THE ACTIVE AND LIFE MEMBERS PRESENT AT A REGULAR OR SPECIAL MEETING. ALL MEMBERS (ACTIVE AND LIFE) MUST BE NOTIFIED OF PROPOSED AMENDMENT AT LEAST ONE WEEK PREVIOUS TO DATE AMENDMENT IS SUBMITTED FOR VOTE BY MAIL OR AT ANY REGULAR OR SPECIAL MEETING.

BY-LAWS

ARTICLE 1

COMMITTEES

SECTION 1. THE STANDING COMMITTEES SHALL BE: EXECUTIVE, 5 MEMBERS; HEARING, 5 MEMBERS; SOCIAL, 5 MEMBERS; WELFARE, 5 MEMBERS.

SECTION 2. THE EXECUTIVE COMMITTEE SHALL CONSIST OF FIVE MEMBERS ELECTED AT THE NOVEMBER MEETING. THE SECRETARY OF THE HOSE COMPANY SHALL BE SECRETARY OF THIS COMMITTEE.

THE EXECUTIVE COMMITTEE SHALL HAVE THE POWER TO ACT AT ANY REGULAR OR SPECIAL MEETING WHEN A QUORUM IS NOT PRESENT EXCEPT FOR THE FOLLOWING:

- a. MAY NOT ENTER INTO WRITTEN CONTRACTS OR AGREEMENTS FOR THE HOSE COMPANY.
- b. MAY NOT ACT ON MEMBERSHIP APPLICATIONS
- c. MAY NOT PAY BILLS EXCEEDING ONE HUNDRED DOLLARS, (\$100.00).

SECTION 3. THE HOSE CCMPANY SHALL ELECT AT THE NOVEMBER MEETING A HEARING COMMITTEE CONSISTING OF FIVE MEMBERS. SAID CCMMITTEE WILL HEAR ALL CHARGES AGAINST OFFICERS AND MEMBERS OF THE CCMPANY. AFTER THE COMMITTEE HAS BEEN NOTIFIED OF A MEETING FOR A HEARING THEY SHALL MEET IN THE STATION WITHIN FIVE DAYS AT WHICH TIME ANY AND ALL PARTIES INVOLVED IN THE INCIDENT SHALL BE HEARD. THE COMMITTEE SHALL RENDER THEIR DECISION AND PENALTY WITHIN THREE DAYS AFTER HEARING IS COMPLETE AND THEIR DECISION SHALL BE FINAL.

THE MEMBERS OF THIS COMMITTEE CANNOT BE OFFICERS OF THE HOSE COMPANY. THEY MAY BE ACTIVE OR LIFE MEMBERS OF THE HOSE COMPANY OR RESPECTABLE CITIZENS OF THE HOSE DISTRICT.

SECTION 4. THE SOCIAL COMMITTEE CONSISTING OF FIVE MEMBERS SHALL ARRANGE ALL SOCIAL AFFAIRS OF THE COMPANY. THEY SHALL HAVE CHARGE OF THE ANNUAL INSTALLATION OF OFFICERS IF HELD. THE COMMITTEE SHALL BE ELECTED FROM MEMBERS OF THE HOSE COMPANY AT THE NOVEMBER MEETING.

SECTION 5. ALL MATTERS RELATING TO THE WELFARE OF THE COMPANY SHALL BE THE DUTY OF THE WELFARE COMMITTEE CONSISTING OF FIVE MEMBERS ELECTED FROM THE FLOOR AT THE ANNUAL MEETING.

SECTION 6. SPECIAL COMMITTEES SHALL BE NOMINATED FROM THE FLOOR OR APPOINTED BY THE PRESIDING OFFICER AT ANY REGULAR OR SPECIAL BUSINESS MEETING.

ARTICLE 11

DUES AND MEMBERSHIP

SECTION 1. DUES IN THIS COMPANY SHALL BE ONE DOLLAR (\$1.00) PER YEAR PAYABLE TO THE TREASURER OR SECRETARY ON OR BEFORE THE NOVEMBER MEETING FOR THE FOLLOWING YEAR. MEMBERS WHO DO NOT FAY THEIR DUES AS SPECIFIED ABOVE ARE AUTOMATICALLY DROPPED FROM MEMBERSHIP IN THE HOSE COMPANY. THE SECRETARY MUST KEEP A RECORD OF ALL MEMBERS WHO HAVE PAID THIER DUES.

SECTION 2. THE MEMBERSHIP OF THE HOSE COMPANY SHALL CONSIST OF ACTIVE. LIFE. AND HONORARY MEMBERS.

SECTION 3. ONLY ACTIVE AND LIFE MEMBERS SHALL HAVE THE POWER TO ATTEND MEETINGS AND VOTE AT SAME.

SECTION 4. ACTIVE MEMBERS SHALL CONSIST OF ALL WHO TAKE AN ACTIVE PART IN THE ADMINISTRATION OR ACTIVITIES OF THE HOSE COMPANY.

SECTION 5. LIFE MEMBERS SHALL CONSIST OF ALL PAST PRESIDENTS AND CHIEFS WHO HAVE SERVED THE COMPANY AT LEAST THREE YEARS IN THE ABOVE CAPACITY. ALSO, ALL ADMINISTRATIVE OFFICERS SERVING THE HOSE COMPANY FOR AT LEAST FIFTEEN YEARS IN THAT CAPACITY SHALL BE DEEMED LIFE MEMBERS. ALL PRESENT LIFE MEMBERS ARE HEREBY DEEMED IN CONTINUING MEMBERSHIP WITHOUT THE PAYMENT OF DUES AS SPECIFIED.

SECTION 6. HONCRARY MEMBERS SHALL CONSIST OF THOSE PERSONS WHO ARE NOT ACTIVE IN THE BUSINESS ACTIVITIES OF THE HOSE COMPANY BUT DO CONTRIBUTE TO THE SUPPORT OF IT.

SECTION 7. MEMBERSHIP TO THE ACTIVE ROLLS SHALL BE BY APPLICATION CNLY. THE APPLICATION SHALL LAY ON THE TABLE FOR ONE MEETING AND BE ACTED UPON AT THE NEXT REGULAR MEETING. VOTE ON ALL APPLICATIONS SHALL BE BY PAPER BALLOT (SECHET VOTE). THREE NEGATIVE VOTES AUTOMATICALLY DISQUALIFIES SAID APPLICANT FROM MEMBERSHIP IN THE HOSE COMPANY. A THREE DOLLAR FEE MUST ACCOMPANY ALL APPLICATIONS. IF SAID APPLICATION IS REJECTED FOR MEMBERSHIP THE FEE WILL BE RETURNED. IF HE IS ACCEPTED SAID FEE WILL BECOME PART OF REGULAR COMPANY FUNDS. IF ANY APPLICANT IS REJECTED HE MAY REAPPLY AFTER A PERIOD OF AT LEAST SIXTY (60) DAYS FROM DATE OF REJECTION. ALL APPLICANTS MUST BE BONIFIED RESIDENTS OF JOHNSTON HOSE NO. 1 DISTRICT.

SECTION 8. ANY APPLICANT ACCEPTED AS A NEW MEMBER SHALL NOT HAVE THE RIGHT TO NOMINATE CR VOTE AT THE NOMINATION AND ELECTION OF OFFICERS FOR ONE YEAR FROM DATE CF ACCEPTANCE.

SECTION 9. ANY APPLICANT WHO ALLOWS HIS MEMBERSHIP TO LAPSE (AS PROVIDED IN SECTION ONE OF ARTICLE 11) MUST REAPPLY FOR MEMBERSHIP AS PROVIDED IN SECTION SEVEN, ARTICLE 11 OF THE BY-LAWS.

SECTION 10. ANY ACTIVE MEMBER WHO FAILS TO ATTEND AT LEAST TWO OF THE REGULAR MEETINGS BEFORE THE NOVEMBER MEETING SHALL FORFEIT HIS RIGHT TO VOTE OR NOMINATE AT THE ELECTION OF OFFICERS OF THIS COMPANY OR TO BE ELECTED OR NOMINATED TO ANY OFFICE OF THE COMPANY. ANY MEMBER WISHING TO BE EXCUSED FROM ATTENDING ANY MEETING MUST PRESENT A FAVORABLE EXCUSE TO THE SECRETARY OR PRESIDENT AT LEAST THREE DAYS PRIOR TO THE MEETING.

ANY ACTIVE MEMBER WHO DOES NOT COMPLY WITH THE ABOVE WILL HAVE HIS NAME POSTED ON THE BULLETIN BOARD IN THE STATION INFORMING HIM THAT HE IS NOT ELIGIBLE TO PARTICIPATE IN BUSINESS MEETINGS FOR THE REMAINDER OF THE YEAR.

SECTION 11. ALL FORMER MEMBERS NOW RESIDING WITHIN OR OUT OF THE HOSE NO. 1 DISTRICT HAVE STATION PRIVILEGES BUT MAY NOT PARTICIPATE IN THE BUSINESS OF THE COMPANY.

SECTION 12. ANY ACTIVE MEMBER SERVING IN THE ARMED FORCES OF THE UNITED STATES SHALL BE CONTINUED AS AN ACTIVE MEMBER DURING HIS TOUR OF SERVICE AND FOR THE REMAINDER OF THE YEAR IN WHICH HE IS DISCHARGED FROM THE SERVICE WITHOUT THE PAYMENT OF DUES AS SPECIFIED.

SECTION 13. THE USE OF PROFANE LANGUAGE IS FORBIDDEN IN THE STATION AND AT ANY MEETING OR GATHERING OF THE HOSE COMPANY.

ARTICLE 111

OFFICERS

SECTION 1. THE OFFICERS SHALL BE ELECTED AT THE ANNUAL MEETING IN NOVEMBER FOR A PERIOD OF ONE YEAR. TEHM OF OFFICE TO BE 1 JANUARY TO 31 DECEMBER INCLUSIVE.

SECTION 2. THE HOSE COMPANY SHALL NOMINATE FOR ALL OFFICERS AND COMMITTEES AS SPECIFIED THE FIRST TUESDAY IN SEPTEMBER AND ELECT THEM BY BALLOT THE FIRST TUESDAY IN NOVEMBER. THE INSTALLATION SHALL BE HELD AT A TIME DESIGNATED BY THE MEMBERSHIP.

SECTION 3. NO MEMBER IN GCCD STANDING SHALL BE DENIED THE PRIVILEGE OF NOMINATING OR VOTING FOR ANY OFFICE, COMMITTEE, OR LEAGUE OR BEING NOMINATED OR ELECTED TO ANY OFFICE, COMMITTEE, OR LEAGUE EXCEPT AS SPECIFIED IN THE BY-LAWS.

SECTION 4. A MAJORITY OF ALL VOTES CAST SHALL ELECT OFFICERS.
A PLURALITY SHALL ELECT COMMITTEES AND LEAGUES.

SECTION 5. IN CASE A VACANCY SHOULD OCCUR IN ANY ELECTED OFFICE DURING THE YEAR, THE CRDER OF VOLUNTARY SUCCESSION IS AS FOLLOWS: VICE PRESIDENT; SECRETARY; TREASURER.

DUTIES OF OFFICERS

SECTION 6. THE PRESIDENT SHALL PRESIDE AT AND MAINTAIN DECORUM AT ALL MEETINGS. HE SHALL ENFORCE ALL RULES AND CALL SPECIAL MEETINGS AS SPECIFIED. IN CASE OF AN EMERGENCY HE MAY CALL A SPECIAL MEETING WITHOUT THE USUAL PROCEDURE. HE SHALL DECIDE ALL QUESTIONS OF ORDER SUBJECT TO AN APPEAL BY ANY MEMBER OF THE COMPANY. HE SHALL NOT BE ENTITLED TO VOTE EXCEPT AT THE ELECTION OF OFFICERS WHEN BALLOTING FOR CANDIDATES AND WHEN VOTING FOR NEW MEMBERS. WHEN A VOTE IS TIE, HE SHALL CAST THE DECIDING VOTE, EXCEPT ON QUESTIONS OF APPEAL FROM HIS DECISION. IF THE PRESIDENT REFRAINS FROM VOTING ON A TIE THE MOTION WILL NOT PASS. HE SHALL APPOINT SPECIAL COMMITTEES WHEN DIRECTED TO DO SO BY THE COMPANY AT A REGULAR OR SPECIAL MEETING. HE SHALL HAVE THE AUTHORITY TO EJECT ANY MEMBER FROM A MEETING BECAUSE OF IMPROPER CONDUCT. HE SHALL BE RESPONSIBLE FOR ALL PROPERTY OWNED BY THE COMPANY AND SHALL REPORT CONDITION OF SAME AT THE ANNUAL MEETING.

THE VICE PRESIDENT SHALL ASSUME_THE_DUTIES OF THE PRESIDENT DURING THE PRESIDENT'S ABSENCE.

THE SECRETARY SHALL KEEP A TRUE RECORD IN TRIPLICATE OF ALL THE PROCEEDINGS AT ALL MEETINGS OF THE COMPANY. HE SHALL KEEP A FILE ON ALL CORRESPONDENCE AND BUSINESS OF THE COMPANY. HE MUST KEEP A RECORD OF ATTENDANCE AT ALL MEETINGS AND POST SAME ON BULLETIN BOARD. HE SHALL CALL THE ROLL OF ALL ACTIVE AND LIFE MEMBERS AT ALL REGULAR AND SPECIAL MEETINGS.

THE TREASURER SHALL BE CUSTODIAN OF ALL FUNDS OF THE COMPANY. HE SHALL DEPOSIT SAME TO CREDIT OF THE HOSE COMPANY AND WITHDRAW ONLY AS DIRECTED BY THE HOSE COMPANY OR THE EXECUTIVE COMMITTEE. HE SHALL MAINTAIN A PETTY CASH FUND NOT TO EXCEED \$30.00.

ARTICLE 1V

MEETINGS

SECTION 1. AS SPECIFIED IN THE CONSTITUTION.

SECTION 2. SPECIAL MEETINGS SHALL BE CALLED BY THE PRESIDENT OR BY ORDER OF THE EXECUTIVE COMMITTEE THROUGH THE PRESIDENT.

SECTION 3. THE OBJECT OF ALL SPECIAL MEETINGS SHALL BE SPECIFIED IN THE CALL.

ARTICLE V

ORDER OF BUSINESS

SECTION 1. AT THE REGULAR MEETING OF THE COMPANY THE ORDER OF BUSINESS SHALL BE AS FOLLOWS:

READING OF THE MINUTES
REPORT OF THE TREASURER
BILLS AND COMMUNICATIONS

REPORTS OF OFFICERS
REPORTS OF STANDING COMMITTEES
REPORTS OF SPECIAL COMMITTEES
UNFINISHED BUSINESS
NEW BUSINESS
ADJOURNMENT

ARTICLE V1

QUORUM

SECTION 1. NO MEETING SHALL BE HELD UNLESS A QUORUM IS PRESENT.

SECTION 2. A QUCRUM SHALL CONSIST OF AT LEAST TWO ADMINISTRATIVE OFFICERS AND TEN ACTIVE OR LIFE MEMBERS. IN THE EVENT A QUORUM IS NOT PRESENT, ARTICLE 1 SECTION 2 WILL PREVAIL.

ARTICLE V11

BUSINESS

SECTION 1. THE BUSINESS OF SAID HOSE COMPANY AT ALL TIMES SHALL BE CONDUCTED IN ACCORDANCE WITH THE USUAL PARLIAMENTARY PROCEDURE AS SET FORTH IN ROBERT'S MANUAL.

ARTICLE V111

SECTION 1. THIS HOSE COMPANY SHALL BE A MEMBER OF THE RHODE ISLAND STATE FIREMEN'S LEAGUE AND THE WOONASQUATUCKET VALLEY FIREMEN'S LEAGUE AND SHALL ELECT DELEGATES AND ALTERNATES TO EACH AT THE ANNUAL MEETING.

ARTICLE 1X

SUSPENSION OF MEMBERS

SECTION 1. DURING SAID SUSPENSION HE SHALL FORFEIT ALL RIGHTS AND PRIVILEGES TO WHICH ANY MEMBER IN GOOD STANDING IS ENTITLED. HE SHALL FORFEIT ALL RIGHTS TO ATTEND ADMINISTRATIVE MEETINGS AND BE DENIED THE RIGHT TO ENTER THE STATION.

THE SUSPENDED MEMBER MUST BE NOTIFIED BY REGISTERED MAIL WITHIN THREE DAYS OF HIS SUSPENSION; THE SUSPENSION TO BE EFFECTIVE THE DAY OF NOTIFICATION.

THE SUSPENDED MEMBER MAY APPEAL HIS CASE TO THE HEARING COMMITTEE WITHIN A PERIOD OF THREE DAYS AFTER HIS SUSPENSION. THE FINDINGS OF THE COMMITTEE SHALL BE REPORTED IN WRITING TO THE MEMBERS AT THE NEXT REGULAR MEETING PROVIDED SUSPENSION HAS BEEN APPEALED AT LEAST SEVEN DAYS BEFORE THE MEETING. THE DECISION AND PENALTY OF THE COMMITTEE SHALL BE FINAL BUT MAY BE REVIEWED UPON REQUEST OF THE SUSPENDED MEMBER AFTER A PERIOD OF AT LEAST THREE MONTHS.

ARTICLE X

BUILDING AND FURNISHINGS

SECTION 1. THE FOLLOWING RESTRICTIONS ARE PLACED ON THE USE OF THE COMPANY'S PROPERTY:

- A. BUNKS WILL NOT BE PLACED IN THE STATION
- B. OVERNIGHT SLEEPING WILL BE STRICTLY PROHIBITED UNLESS APPROVED BY THE MEMBERSHIP.
- C. A MIDNIGHT CURFEW WILL BE IN FORCE FOR ALL PERSONS ENTERING THE STATION EXCEPT DURING EMERGENCIES.
- D. THE PROPERTY WILL NOT BE RENTED OR LOANED TO ANY ORGANIZATION EXCEPT AS STATED IN SECTION 2 OF THIS ARTICLE.

SECTION 2. THE BUILDING MAY BE USED FOR TOWN ELECTIONS PROVIDED ADVANCE NOTIFICATION AND PROPER PROVISIONS HAVE BEEN MADE WITH THE COMPANY.

THE RECREATION ROOM AT THE REAR OF THE BUILDING WILL BE FOR THE USE OF THE MEMBERS. PERMANENT AND CALL FIREMEN WILL ALSO HAVE THIS PRIVILEGE WITH THE APPROVAL OF THE MEMBERSHIP.

SECTION 3. ANY DEFACING, REMOVALS, ABUSE OR OTHER ACTS AGAINST THE PROPERTY OR FURNISHINGS BELONGING TO THE COMPANY WILL RESULT IN THE GUILTY PERSON OR PERSONS FORFEITING ALL RIGHTS GRANTED IN THE BY-LAWS AND CONSTITUTION OF THIS COMPANY INCLUDING THE RIGHT TO ENTER THE STATION.

THE ABOVE PENALTIES ALSO COVER PERMANENT AND CALL FIREMEN WHO ARE NOT MEMBERS OF THE VOLUNTEER COMPANY. ANY RESTRICTIONS BROKEN IN SECTION 1 ABOVE WILL ALSO BE COVERED BY THIS SECTION.

THE FOLLOWING ARE THE PROPOSED AMENDMENTS TO THE CONSTITUTION AND BY-LAWS OF THE JOHNSTON HOSE CO. #1 VOLUNTEER FIRE COMPANY.

PURPOSE: THE PURPOSE OF THESE AMENDMENTS SHALL BE TO EMBRACE AND ENGCURAGE THE YOUTHS OF GOOD CONDUCT IN THE JOHNSTON HOSE CO. #1 VOLUNTEER FIRE COMPANY DISTRICT, THAT THEY MAY ENJOY THE USE OF THE PREMISES, AS WILL BE INDICATED IN THE BY-LAWS AND CONSTITUTION, AND INSTRUCTION IN FIRE PREVENTION AND CTHER SERVICES, AS MAY BE ALLOWED FROM TIME TO TIME BY THE GOVERNING BODY OF THIS COMPANY.

THE AMENDMENTS ARE AS FOLLOWS

ARTICLE 111 SECTION 1 OF THE CONSTITUTION SHALL READ

THE MEMBERS SHALL BE PLACED IN FOUR CLASSES, NAMELY, ACTIVE, LIFE, HONCRARY AND JUNIOR MEMBER.

ARTICLE 111 SECTION 3

AN APPLICANT FOR JUNIOR MEMBERSHIP MUST BE AT LEAST 10 YEARS OF AGE, BE A RESIDENT OF THE JOHNSTON HOSE CO. #1 FIRE DISTRICT, AND SHALL APPLY BY APPLICATION ONLY.

THE PROPOSED AMENDMENT TO ARTICLE 2 OF THE BY-LAWS SHALL READ SECTION 6A JUNIOR MEMBERS SHALL CONSIST OF THOSE YOUTHS OF GOOD CONDUCT RESIDING IN THE JOHNSTON HOSE CO. #1 VOLUNTEER FIRE COMPANY DISTRICT AND SHALL BE SPONSORED BY ANY ACTIVE OR LIFE MEMBER IN GOOD STANDING OF SAID FIRE COMPANY. THEIR APPLICATION SHALL BE ACCOMPANIED BY THE SUM OF ONE DOLLAR AND PRESENTED BY THE SPONSOR AT ANY REGULAR MEETING UNDER NEW BUSINESS.

THE SPONSOR SHALL THEN INDICATE THE MERITS AND THE QUALIFICATIONS OF THE APPLICANT. THE APPLICATION MAY THEN BE VOTED AND VOTING SHALL BE BY SECRET BALLOT. THE APPLICANT SHALL BE ACCEPTED BY A YES VOTE OF AT LEAST 2/3 OF THE MEMBERS VOTING.

UPON ACCEPTANCE THE JUNIOR MEMBER MAY ENTER AND USE THE PREMISES. HIS ACTIVITIES SHALL BE GOVERNED AT ALL TIMES BY SENIOR MEMBERS OR OTHER AUTHORITY PRESENT AND THE GOVERNING BODY OF THIS COMPANY.

THE JUNIOR MEMBER SHALL HAVE NO POWER TO VOTE. HE WILL NOT BE ALLOWED TO ATTEND MEETINGS, EXCEPTING AT THE EXPRESS REQUEST OF THE GOVERNING BODY.

HIS MEMBERSHIP WILL AUTOMATICALLY TERMINATE ON DECEMBER 31 OF EACH YEAR, THEREFORE, AT THE NOVEMBER MEETING PREVIOUS TO THE EXPIRATION DATE, HE WILL SUBMIT THE SUM OF ONE DOLLAR AND HIS APPLICATION SHALL BE REVIEWED AND REVOTED UPON. IF THE APPLICATION IS NOT REAFFIRMED BY A 2/3 YES VOTE OF THE MEMBERS PRESENT, HIS MEMBERSHIP WILL AUTOMATICALLY TERMINATE AND THE SUM OF ONE DOLLAR WILL BE REFUNDED. UPON TERMINATION OF HIS MEMBERSHIP HE WILL NO LONGER BE ALLOWED ENTRY TO THE PREMISES OR ANY OTHER STATION PRIVILEGES.
