The specific purpose or purposes for which the corporation is organized are:

THE GOAL OF CANEIWALK IS DOING WORKSHOPS OF SELF ADVOCACY FOR YOUTH AND ADULTS WITH DISABILITIES AS WELL AS THOSE INTERESTED IN HELPING BE ADVOCATES FOR DISABILITY COMMUNITY, WE ALSO WANT TO HELP HIGH SCHOOL GRADUATES WITH DISABILITIES IN RI BY PROVIDING THEM WITH RESOURCES AND A YEARLY SCHOLARSHIP. THE LAST AND THE MOST IMPORTANT IS ASSISTING PEOPLE WITH DISABILITIES THAT ARE IN EXTREME HARDSHIP WITH EITHER FINANCIAL SUPPORT OR BY SPONSORING MEDICAL PRODUCTS OR SERVICES SUCH AS WHEELCHAIRS, CANES, WALKERS, PROSTHETICS, PHYSICAL THERAPY, ETC.
