FIRST. To associate ourselves together with the intention of forming a corporation

In addition to the foregoing, said corporation shall have the following powers and authority, viz:—(See §§ 7-6-7. 7-6-8 of the General Laws.)					
To do any lawful act which is necessary or proper to accomplish the purposes of its incorporation. Without limiting or enlarging the effect of this general grant of authority, it is hereby specifically provided that every such corporation shall have power:					
 (a) to have perpetual succession in its corporate name unless a period for its duration is limited in its articles of associa- tion or charter; 					
(b) to see and be seed in its corporate name;(c) to have and use a common seal and alter the same at pleasure;					
(d) to elect such officers and appoint such agents as its purposes require, and to fix their compensation and define their duties;					
(a) to make by-laws not inconsistent with the Constitution or laws of the United States or of this state, or with the corporation's charter or articles of association, determining the time and place of bolding and the manner of calling and of conducting meetings of its members and directors, the manner of electing its officers and directors, the mode of voting by proxy, and the number, qualifications, powers, duties and term of office of its officers and directors, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs; (f) to make contracts, incur liabilities and borrow money.					
Sald corporation shall be entitled to take, hold, transmit and convey real and personal estate to an amount not exceeding					

in all one bundred fifty thousand dollars (\$150,000): provided, however, that the foregoing limitation shall not apply to corporations organized for the purposes of fostering, encouraging and assisting the physical location, settlement or resettlement of industrial and manufacturing enterprises within the state, and to whose members no profit shall enter. If any corporation subject to the foregoing limitation desires to take and bold property to an amount exceeding one bundred fifty thousand dollars (\$150,000) either originally or by amendment, such privilege shall be granted only by the general assembly on petition thereto

FOURTH. Said corporation shall be located in Central Falls, Rhode Island.

(Further provisions not inconsistent with law)

FIFTH The corporation shall have the power, either directly or indirectly, either alone or in conjunction or cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment, fostering or attainment of any or all of the purposes for which the corporation is organized, and to aid or assist other organizations whose activities are such as to further accomplish, foster, or attain any of such purposes. Notwithstanding anything herein to the contrary, the corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended, and the regulations promulgated thereunder.

SIXTH This corporation is not organized for profit, and no part of the net earnings of the corporation shall inure to the benefit of any member (except that reasonable compensation may be paid for services rendered to and for the corporation). In the event of the liquidation of the corporation, whether voluntary or involuntary, no member shall be entitle to any distribution or division of the corporation's property or the proceeds thereof, and upon such liquidation, the balance of all money, assets and other property of the corporation, after the payment of all it debts and obligations, shall, pursuant to a resolution of the corporation or an order of a court of competent jurisdiction in the State of Rhode Island, be used by, or distributed to, an organization or organizations

SEVENTE which would then qualify under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended and the regulations promulgated thereunder, and which will use such property to accomplish the purposes for which this corporation is constituted.

SEVENTH The powers of the corporation shall be vested in its member the number and election of which will be fixed by or in the manner
