



It is enacted by the General Assembly as follows:

SECTION 1. William A. Hickey, Martin F. Reddy, Anthony Bove, John H. McKenna, Joseph A. Laliberte, Cornelius J. Holland, Joseph M. L. Giroux, Gedeon Laverdiere, Edward Higney and Thomas V. Cassidy, their associates and successors are hereby constituted a body corporate by the name of Catholic Teachers' College of Providence, and they and their successors, and such as shall be duly elected members of said corporation, shall be and remain a body corporate by that name forever. And for the orderly conducting the business of said corporation, it shall have power and authority from time to time as occasion may require to elect a president, vice president, secretary and treasurer, and such other officers of said corporation as may be found necessary and to declare the duties and tenures of their respective offices; and also to remove any member from the same corporation, when in its judgment he shall be rendered incapable by age, or otherwise, of discharging the duties of his office, or shall neglect or refuse to perform the same; and also from time to time to elect new members of the said corporation.

The said corporation shall have a common seal, which it may alter or renew at its pleasure, and all deeds sealed with the seal of said corporation and signed by its order shall when made in its corporate name be considered in law as the deeds of said corporation; and said corporation may sue and be sued in all actions, real, personal or mixed, and may prosecute the same to

final judgment and execution by and in its said corporate name; and said corporation shall be capable of taking and holding in fee simple or any less estate by gift, grant, bequest, devise or otherwise any lands, tenements or other estate, real or personal, for the purposes of this act.

SEC. 5. The clear rents and profits of all the estate, real and personal, of which the said corporation shall be seized and possessed shall be appropriated to the maintenance, upkeep and endowment of said college in such manner as shall most effectually promote virtue and piety and learning in such of the languages and of the liberal arts and sciences, including particularly the science of education and the art of teaching, as shall be recommended from time to time by the said corporation, it conforming to the will of any donor or donors in the application of any estate which may be given, devised or bequeathed for any particular object connected with the college.

SEC. 6. All the estate both real and personal of said corporation wheresoever located, whatever its condition or whenever acquired, when used for educational purposes, shall be exempt from taxation by any municipal corporation of this state and shall also be exempt from all state taxes.
