EXHIBIT A

a) The business of the Company shall be: To design, operate, charter, build, construct, finish, equip, fit out, refuel, lubricate, service, repair, overhaul, renovate, recondition, refinish, clean, paint, berth, dock, store, maintain and generally keep in operating condition, buy, sell, display, import, export, lease as lessor of lessee, act as insurance and credit brokers and agents in connection with, and generally deal in and with any lawful capacity, any and all kinds of boats, ships, yachts, watercraft, vessels of all types, marine and marine equipment and, in connection therewith and independent thereof, to own, operate, buy, sell, mortgage, maintain, manage, lease as lessor or lessee, license the use of, as licensor or licensee, obtain, receive, distribute and grant franchises, options, royalties and rights of all kinds in respect of, and generally deal in and with, whether as principal, agent, broker, or otherwise, any and all kinds of improved and unimproved real and personal property and riparian rights, fuels, lubricants, equipment, supplies, accessories, berthing, docking, wharf and working areas, sites, basins, boat and shipping yards, mobile, portable and stationary establishments for selling, supplying, and rendering services on boats, yachts, ships, watercraft, marine and marine equipment, and for selling and dealing in goods, wares, and merchandise capable of use in or about boats, watercraft, marine and marine equipment, yachts, ships and refreshment and other stands and facilities, and to do everything necessary, useful and convenient in furtherance of the objects of the corporation, including the furnishing of services of skilled and unskilled personnel, and to engage in any lawful act or activity for which limited liability companies may be formed under the Rhode Island Limited Liability Act (the "Act"), except (a) rendering "professional services" as defined in the Act; and (b) transacting the business of an insurance company or a surety or indemnity company. Except as expressly provided, the foregoing statement is not intended to limit or restrict in any manner the exercise of all powers conferred upon the Limited Liability Company by the Act.
