#### AN ACT

TO VACATE THE FORFEITURE OF THE CHARTER OF SOUTH FOSTER VOLUNTEER FIRE DEPARTMENT, NO. 1

### It is enacted by the General Assembly as follows:

SECTION 1. Notwithstanding any other general or special law to the contrary, the forfeiture of the charter of the SOUTH FOSTER VOLUNTEER FIRE DEPARTMENT, NO. 1 incorporated at the January session, 1929, be vacated and said corporation shall thereupon be entitled to all of the privileges, benefits, and powers and subject to the same duties and liabilities as though no forfeiture of its charter had taken place.

The necessity of filing any and all reports and the payment of any fees hereunder or by any special or general law of this state is hereby relieved and excused.

SEC. 2. This act shall take effect upon its passage and any acts and parts of acts inconsistent herewith are hereby repealed.
