SECTION 1. An act, entitled "An act to incor-
porate the Church of the Mediator, in Providence,"
passed at the January session, A. D. 1868, as
amended by an act passed at the January session.
A. D. 1916, is hereby further amended so as to
authorize the Church of the Mediator, in Provi-
dence, to take, hold, transmit and convey real and
personal estate to an amount not exceeding five
hundred thousand dollars.

Sec. 2. This act shall take effect upon its passage,
