ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Olympic Physical Therapy & Sports Medicine, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:

The formation of a professional service corporation pursuant to
Section 7-5.1-1 et seq. of the Rhode Island General Laws to render
professional services by physical therapists licensed to practice in
the State of Rhode Island and to do such things as are necessary or
proper in connection therewith and to engage in any lawful activity
within the purposes for which said corporations may be organized under
the general corporation laws of the state of Rhode Island as the same
may be amended from time to time.

4. The aggregate number of shares which the corporation shall have authority to issue is:

5. Provisions (if any) dealing with the preemptive right of shareholders pursuant to § 7-1.1-24 of the General Laws, 1956, as amended:

Restrictions on the sale of stock are contained in the bylaws.

6. Provisions (if any) for the regulation of the internal affairs of the corporation:

The business of the corporation shall be managed by the shareholders
of the corporation. There shall be no Board of Directors.
