FIRST. To associate ourselves together with the intention of forming a corporation under and by virtue of the powers conferred by Article III of Chapter 248 of the General Laws of the State of Rhode Island.

SECOND. Said corporation shall be known by the name of PROVIDENCE COMMUNITY FUND, INC.

THIRD. Said corporation is constituted for the following purposes:

- (1) To promote, develop, maintain and co-ordinate social welfare and charitable work; and

The classes of work herein described as social welfare and charitable work shall be deemed to include only those classes

of work which may be conducted by corporations contributions to which are at the time deductible under the federal income tax law in the determination of an individual's net income.

Said corporation shall also have and possess all the powers and authorities conferred by Section 75 of Chapter 248 of the General Laws of the State of Rhode Island upon corporations organized under Article III of said Chapter.

FOURTH. Said corporation shall be located in the City of Providence in the State of Rhode Island.
