We are in receipt of your correspondence dated September 17, 2004, informing this office of a possible problem with the corporation's registered office.


Our records indicate the corporation's certificate of incorporation was revoked in this office on November 7, 2003 for failure to file the 2003 annual report. At the time of revocation the corporation's registered agent/registered office appeared to be viable as the 2003 annual report, 60-day revocation notice and certificate of revocation was never returned to this office by the United States Postal Service.

In accordance with the provisions of Title 7 Chapter 1.1 of the Rhode Island General Laws as amended, corporations are to maintain at all times a registered agent/registered office for the service of process and file with this office an annual report between the months of January and March 1 of each calendar year.

To reinstate the corporation's certificate of incorporation it must file with this office a 2003 and 2004 annual report (\$50.00 ea.) a Statement of Change of Registered Agent (\$20.00,) 1 year penalty fee (through 11/7/04 - 2 years if reinstatement is filed after 11/7/04 (\$50.00,)) and a letter of good standing from the Rhode Island Division of Taxation for the purpose of "REINSTATEMENT." The forms required for filing are enclosed.
