ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Sun Management Group, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:

To operate a yacht charter business, and to do all other lawful business for which corporations may be incorporated under the Rhode Island Business Corporation Act, and to have all of the powers conferred upon corporations organized under the Rhode Island Business Corporation Act.

4. The aggregate number of shares which the corporation shall have authority to issue is:

Original Articles of Incorporation

Sun Management Group, Inc.

5.
 1. Shareholders shall have a preemptive right to acquire unissued or treasury shares or securities convertible into shares or carrying a right to subscribe to or acquire shares, as provided in Sec. 7-1.1-24 of the General Laws of R.I. 1956, as amended, and shall also have the right to acquire any shares issued for services or property other than money.
 2. No shareholder shall transfer, alienate or in any way dispose of any shares of the corporation unless such shares shall first be offered for sale to the corporation. The corporation reserves and shall have the exclusive right and option to purchase said shares at a price equal to the lowest appraised value thereof, with thirty (30) days after said offer. After the expiration of said time, the shareholder, if the corporation shall not have exercised its option to purchase said shares, shall be free to transfer, alienate or otherwise dispose of said shares without any restrictions whatsoever.
6.
 1. The corporation shall have no Board of Directors. All of the powers of a Board of Directors in the conduct and management of the corporate affairs are assumed by the shareholders.
 2. The corporation may issue and sell its authorized shares without par value from time to time for such consideration as may be fixed from time to time by the unanimous vote of the shareholders of the corporation, which may consist of money or property, including shares or securities of any corporation, or services performed.
