Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is SEIU EDUCATION AND SUPPORT FUND, Inc.

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THIRD: THE CORPORATION IS ORGANIZED AND WILL BE OPERATED EXCLUSIVELY FOR CHARITABLE,
RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(C)(3) OF THE INTERNAL
REVENUE CODE OF 1986 (AS THE SAME MAY BE AMENDED OR SUPERSEDED, THE "CODE"),
INCLUDING:
A. RESEARCHING AND INVESTIGATING STRATEGIES FOR ADDRESSING WORKPLACE SAFETY,
HEALTHCARE ACCESS AND AFFORDABILITY, COMMUNITY ECONOMIC DEVELOPMENT,
CLEAN
ECONOMY, AND WORKER RIGHTS ISSUES AND EDUCATING THE GENERAL PUBLIC ON THESE
ISSUES;
B. PROVIDING EDUCATION AND INSTRUCTIONAL PROGRAMS TO WORKERS IN THE SERVICE
INDUSTRY;
C. PROTECTING HUMAN RIGHTS AND PROMOTING HEALTH AND SAFETY THROUGH THE
PROVISION OF
FINANCIAL GRANTS AND/OR FINANCING TO ORGANIZATIONS WITH THOSE GOALS, ALONG
WITH THE
PRESENTATION OF EDUCATIONAL FORUMS FOR THE GENERAL PUBLIC ON THESE SAME
SUBJECTS;
AND
D. MAKING DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS
UNDER
SECTION 501(C)(3) OF THE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE
FEDERAL TAX
CODE.
E. TO EXERCISE ANY OR ALL POWERS OF CORPORATIONS FORMED UNDER THE DISTRICT OF
COLUMBIA
NONPROFIT CORPORATION ACT THAT MAY BE NECESSARY OR CONVENIENT TO
ACCOMPLISHING THE

ABOVE-DESCRIBED PURPOSES AND ANY OTHER LAWFUL PURPOSE.
IN PURSUIT OF THE ABOVE PURPOSES, THE CORPORATION SHALL HAVE THE POWERS TO DO
ALL
THINGS
NECESSARY, PROPER AND CONSISTENT WITH OBTAINING AND MAINTAINING ITS TAX-
EXEMPT
STATUS UNDER SECTION 501(C)(3) OF THE CODE. NOTWITHSTANDING ANYTHING HEREIN TO
THE
CONTRARY, THE CORPORATION'S PURPOSES WILL BE LIMITED EXCLUSIVELY TO EXEMPT
PURPOSES
WITH THE MEANING OF SECTION 501(C)(3) OF THE CODE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

FOURTH: NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE
BENEFIT OF
OR BE DISTRIBUTED TO ANY DIRECTOR, EMPLOYEE OR OTHER INDIVIDUAL, PARTNERSHIP,
ESTATE,
TRUST OR CORPORATION HAVING A PERSONAL OR PRIVATE INTEREST IN THE
CORPORATION, EXCEPT
THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE
COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS
IN
FURTHERANCE OF THE CORPORATION'S EXEMPT PURPOSES SET FORTH IN ARTICLE THIRD OF
THESE
ARTICLES OF INCORPORATION. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE
CORPORATION SHALL
CONSTITUTE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO
INFLUENCE
LEGISLATION OR ANY INITIATIVE OR

REFERENDUM BEFORE THE PUBLIC, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR
INTERVENE IN (INCLUDING BY PUBLICATION OR DISTRIBUTION OF STATEMENTS), ANY
POLITICAL
CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE.
NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL
NOT CARRY
ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON: (A) BY AN ORGANIZATION EXEMPT
FROM
FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE CODE, OR THE CORRESPONDING
SECTION
OF ANY FUTURE FEDERAL TAX CODE, OR (B) BY AN ORGANIZATION, CONTRIBUTIONS TO
WHICH ARE
DEDUCTIBLE UNDER 170(C)(2) OF THE CODE, OR THE CORRESPONDING SECTION OF ANY
FUTURE
FEDERAL TAX CODE.
