

EXHIBIT A

Any stockholder including the heirs, assigns, executors or administrators of a deceased stockholder, desiring to sell or transfer any stock of this Corporation shall first offer such stock to the Corporation through its Board of Directors at not more than the book value of such stock as shown upon a financial statement of the Corporation to be drawn as of the first of the month preceding the offer, provided, however, that the Corporation shall exercise its right to purchase within thirty (30) days after the stockholder shall have notified it in writing of his desire to sell said shares, and if the Corporation shall decide to purchase said shares, such stockholder shall, upon the proper tender of the price thereof, transfer to the Corporation his shares so sold, and if the Corporation shall elect not to purchase said shares within thirty (30) days, then such stockholder may at any time after the expiration of said thirty (30) days, sell shares to any other party but not at less than the price at which the same was offered to this Corporation.
