On April 22, 2002, this office issued a 60-day revocation notice to the corporation's current registered agent of record, Robert B. Urquhart, 645 New London Avenue, Cranston, RI 02920, notifying the corporation of its failure to file the 2001 annual report. I have checked the corporate file and can find no evidence of receipt of the 2001 annual report. The agent may be a Rhode Island resident or a corporation (Domestic or Foreign) qualified to conduct business in this state. The registered office must be a physical Rhode Island street address. A Post Office Box is not acceptable unless it is accompanied by a street address.
