The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Church of the Apostles

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:
Church of the Apostles is organized exclusively for religious, charitable, and educational purposes
within the meaning of section 501(c)(3) of the Internal Revenue Code, and it is more specifically
organized as a Christian church engaging in worship in the orthodox Anglican tradition as part of
the one holy catholic and apostolic Church.

4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
In the event of the dissolution of the corporation, the assets shall be distributed for one or more
exempt religious, charitable, or educational purposes within the meaning of section 501(c)(3) of
the Internal Revenue Code.
