It is enacted by the General Assembly as follows:

SECTION 1. The time within which THE CHARLES SAMDPERIL HUMANITARIAN

MEMORIAL FOUNDATION incorporated on August 26, 1982, shall file the reports for the

3 years 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017,

2018 and 2019, as required under the provisions of Chapter 6 of Title 7 of the General Laws,

5 1956, is hereby extended to the 31st day of December, A.D., 2019, if said corporation shall file in

6 the office of the secretary of state before December 31, 2019, the reports which it should have

filed in the said years and shall pay to the secretary of state the filing fees therefor, having

previously thereto paid to the general treasurer for the use of the state such sum as the attorney

9 general shall decide should be paid by said corporation as a compromise for the penalty or

10 penalties for its failure to file such reports then the forfeiture or revocation of the charter of said

11 corporation shall thereupon, to wit, upon the filing of said reports and the payment of said fees, be

12 vacated and said corporation shall thereupon be entitled to all of the privileges, benefits and

13 powers and subject to the same duties and liabilities as though no forfeiture or revocation of its

14 said charter had taken place.

SECTION 2. This act shall take effect upon passage.

Dear Mr. Schloss:

The Office of the Attorney General has received your request on behalf of The Charles Sapderil Humanitarian Memorial Foundation ("Foundation") that this Office waive penalty fees for the Foundation's failure to submit filings to the Secretary to State from 2003 to 2019. The reason stated for your request is that the above-named entity is a non-profit and these penalties would create a hardship.

Pursuant to R.I. Gen. Laws § 7-1-23, the Attorney General may "compromise" any penalty and permit the payment of a "smaller sum" than what has been assessed. There is, however, no provision for complete waiver of fees.

After reviewing the information that you provided to this Office and having found no consumer complaints or lawsuits against this company, this letter is to inform you that the Attorney General authorizes a reduction of the \$400.00 penalty imposed on the Foundation to \$50.00. This is contingent; however, on the entity submitting the missing filings to the Secretary of State from 2003 to 2019 and paying the total fee amount of \$340.00 (\$20.00 per filing).

You must provide a copy of this letter to the Secretary of State in order reduce penalty fees. If you have any questions, please contact this Office.
