EXHIBIT A TO ARTICLES OF INCORPORATION

JNI CONSTRUCTION CO.

5. No shareholder shall sell any stock of the corporation held by him or her without first giving written notice to the corporation of his or her intention to sell the same and giving the corporation the right to purchase said stock at the lowest price at which he or she is willing to sell before the same shall be sold by him or her to any other party.

The corporation shall have 30 days from the receipt of such offer within which to exercise the right to purchase the stock so offered to it. If such offer is not accepted within such time or if the corporation, through the Board of Directors, waives this right of first refusal, the shareholder shall be at liberty to sell such stock for not less than the price named by him or her set forth in the notice. Said notice to the corporation shall also include the names and addresses of the proposed transferee or transferees.
