ORDERED

2. Defendant shall accept the filing of said aforementioned Annual Reports for said years upon the payment of the filing fees.

3. Upon filing said Annual Reports and the payment of the filing fees, the Defendant is ordered to reinstate the Corporate Charter of the Plaintiff Corporation and consider said corporation in good standing retroactive to the date of forfeiture (February 15, 1986).

4. Plaintiff hereby waives any right to a hearing de novo pursuant to R.I.G.L. 7-1.1-133.



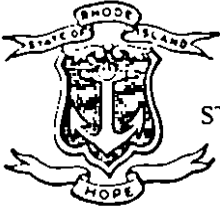
