EXHIBIT A

No stockholder shall sell any stock of the Corporation held by him without first giving written notice to the Corporation of his intention to sell the same and giving the Corporation the right to purchase said stock at the lowest price at which he is willing to sell before the same shall be sold by him to any other party.
