The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

The purposes of the Corporation are to:

- 1) Enlarge the body of knowledge relating to Amyotrophic Lateral Sclerosis (ALS)
- 2) Educate and inform the general public as to the nature of ALS
- 3) To help the patient and the patients family to live as full and normal a life as possible
- 4) To aid patients through the loan of equipment or by other means
- 5) To encourage scientific research for the prevention, alleviation, care, treatment and cure of ALS patients
- 6) To do all the above, alone or in conjunction with others interested in the same

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are: (Note 1)

In the event of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses thereof, be distributed to another organization exempt under Section 501 (c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws, or to the Federal Government, or State or Local Government for a public purpose.
