ORIGINAL ARTICLES OF ASSOCIATION (NON-BUSINESS CORPORATION)

Know all Men by these Bresents. That we Albert P. Rueret of the town of Foster, H. Nord Kitchen of the city of Warwick, Gardner M. Yeaw of the city of Cranston, David I. Hiltibrand of said city of Granston, Donald F. Culton of the town of Cumberland, and Glibert G. Rachon of said city of Warwick all in the State of Rhode Island all of lawful age, hereby agree to and with each other:

FIRST. To associate ourselves together with the intention of forming a corporation under and by virtue of the powers conferred by Chapter 7-6 of the General Laws of Rhode Island, as amended.

SECOND.	Said corporation shall be known by the name of Scottish Rite Cathedral, Inc.

In addition to the foregoing, said corporation shall have the following powers and authority, viz:—(See §§ 7-6-7, 7-6-8 of the General Laws.)

Said corporation shall be entitled to take, hold, transmit and convey real and personal estate to an amount not exceeding in all one hundred fifty thousand dollars (\$150,000); provided, however, that the foregoing limitation shall not apply to corporations organized for the purposes of fostering, encouraging and assisting the physical location, settlement or resottlement of industrial and manufacturing enterprises within the state, and to whose members no profit shall caure. If any corporations subject to the foregoing limitation desires to take and hold property to an amount exceeding one hundred fifty thousand dollars (\$150,000) either originally or by amondment, such privilege shall be granted only by the general assembly on petition thereto

To do any lawful act which is necessary or proper to accomplish the purposes of its incorporation. Without limiting or enlarging the effect of this general grant of authority, it is hereby specifically provided that every such corporation shall have
