ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST. The name of the corporation is Family Tree Counseling, Inc.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND. The period of its duration is (if perpetual, so state) PERPETUAL.

THIRD. The purpose or purposes for which the corporation is organized are:

1. To provide Clinical Social Work services to children, adults, families, and groups.
2. To promote positive growth and development in individuals, families, and groups whose past, present, and or future feelings, thoughts, and or behaviors have resulted in discomfort and or dysfunction.
3. To promote the highest level of functioning in individuals, families, and or groups by means of adaptation and or amelioration of societal, interpersonal, and or intrapersonal woes through the Social Work process.

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is:
