SIXTH: Provisions (if any) for the regulation of the internal affairs of the corporation:

In case any stockholder desires to sell any of his or her stock, the said Ledger Domain, Inc. shall have the right to purchase said stock at the lowest price at which said stockholder is willing to sell, provided, however, that in case any stockholder desires to sell any of his stock he shall give written notice of such desire to sell and shall disclose in such notice the lowest price at which said stockholder is willing to sell said stock, and said corporation shall, within 30 days after receipt of said notice exercise its right to purchase or the right of pre-emption in such instance shall be lost.
