KNOW ALL MEN BY THESE PRESENTS,

That the Providence Redevelopment Agency, a body corporate and politic, created by and duly organized under the laws of the State of Rhode Island, hereby constitutes and appoints Sidney Kramer of the City of Providence in the State of Rhode Island, to be its true and lawful attorney, with authority, for and in behalf of said body to accept and acknowledge service of all process, including the process of garnishment, against said body in said State in any action, suit, or other proceeding which may be brought against said body in any court in said State and upon whom all such process, including the process of garnishment, against said body in said State may be served, and who, in case of garnishment when the fees therefor shall have been paid or tendered, may for and in behalf of said body make the affidavit required by law in such cases; and said body does hereby admit and agree that any such acceptance or acknowledgement of service of process by said attorney, and any such service of process upon said attorney, shall be deemed sufficient. This appointment is to continue in force for the period of time and upon the terms and conditions provided in Section 39 of Chapter 3654 of the Public Laws of Rhode Island, 1956.
