If for any reason the corporation is unable to or fails to purchase such stock, such stock shall be offered to the other stockholders of record in proportion to the number of shares they hold for a period of thirty (30) days, at a price not lower than which it was first offered to the corporation.

If the remaining stockholders shall elect not to purchase said stock, the stockholder shall be at liberty to sell his stock to any other party at a price not less than the price at which is was first offered to the corporation and to the remaining stockholders.
