

**RECEIVER'S FINAL REPORT AND REQUEST FOR APPROVAL OF FEES,
EXPENSES AND CLAIMS RECOMMENDATION**

NOW COMES Vincent A. Indeglia, Esq., in and only in his capacity as the Permanent Receiver for Alpha Dog Training Center, LLC (hereinafter referred to as "Alpha Dog") and hereby provides this Court with a Final Report and Requests for Approval of Fees and Expenses. The Receiver further provides his Claims Recommendations and request to make payments on such claims. In support thereof, the Receiver provides the following:

1. Alpha Dog is a Rhode Island limited liability company with an address of 70 Industrial Drive, Cumberland, Rhode Island, and operates a dog training, grooming and kennel business.
2. On June 3, 2019, this Court appointed Vincent A. Indeglia, Esq., as the Temporary Receiver over the Respondent, Alpha Dog.
3. Thereafter, the Receiver, under the authority of the Court Order, made the determination to continue the operation of the business of Alpha Dog as it was thought to be in the best interest of the creditors. Your Receiver engages the services of the current management team and continued to employ all of the company employees. Your Receiver secured the proper insurances, marshalled all of the assets, changed over the bank accounts to a Receivership account and made contact with all known creditors.
