ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Angel Flight Rhode Island, Inc.

2. The period of its duration is (if perpetual, so state) perpetual

3. The specific purpose or purposes for which the corporation is organized are:
the provision of charitable or charitably-assisted long-distance air transport for ambulatory outpatients, and for medically or non-
medically related family or disaster situations where there are no other reasonable alternatives for the families in need;
transport of medical supplies, organs, organ donors, blood and medical personnel when such transport is important to the timely
delivery of medical services; the provision of patient assistance through the use of aircraft owned or leased by the organization
or through aircraft provided for service at no cost by volunteer pilots registered with the organization; coordination and
cooperation with all similar volunteer pilot organizations flying for public benefit; and the provision of educational information
to the public and to the travel and health care industries related to the full scope of available long-distance patient air transport
options.

4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:
Angel Flight Rhode Island, Inc. shall have one class of members. Angel Flight New England, Inc. is the sole voting
member of Angel Flight Rhode Island, Inc. and elects or removes the directors of Angel Flight Rhode Island, Inc.
Any amendment to the Articles or Bylaws of Angel Flight Rhode Island, Inc. must be approved by Angel Flight New England,
Inc.
