ARTICLES OF INCORPORATION

The undersigned acting as incorporator (s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Michael Perri & Sons, Inc.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND: The period of its duration is (if perpetual, so state) Perpetual

THIRD: The purpose or purposes for which the corporation is organized are:

To engage in the general land improvement buisness, drainage, drain laying, sewerage disposal, grading, landscape gardening, buying, selling and dealing in any and all articles of personal property of every kind and nature allied thereto, and furnishing all work and labor in relation thereto, and engaging in any other lawful activity.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is:

FIFTH: Provisions (if any) dealing with the preemptive right of shareholders pursuant to §7-1.1-24 of the General Laws, 1956, as amended:

The corporation shall have a lien and also a right to pre-emption upon the stock of the stockholders in the event of the sale or transfer of stock of any stockholder which lien and right of preemption shall be enforced in accordance with the provisions of the by-laws of the corporation.
