## EXHIBIT A

## AMENDMENT TO ARTICLES OF ORGANIZATION

1. That Article 3 of the Articles of Incorporation of the Corporation filed with the Rhode Island Secretary of State on July 23, 1999, be amended in its entirety to read as follows:

To acquire and maintain information relative to, and to promote the sound stewardship of the natural and cultural resources, to improve the water quality, to conserve open space, woodlands, wetlands and geological features; to protect rare native plant and animal species; to aid in the preservation of cultural, historical and geological sites; to increase outdoor recreation opportunities; and to conduct scientific and educational programs relating to the environment of the Roaring Brook Watershed in Coventry and West Greenwich, Rhode Island, and to carry on such other lawful activities for which a corporation may be formed under Title 7, Chapter 6 of the Rhode Island General Laws (1956), as amended.
