ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST. The name of the corporation is
Alexander Scagnelli, M.D., P.C.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND. The period of its duration is (if perpetual, so state) perpetual

THIRD. The purpose or purposes for which the corporation is organized are:

The corporation is organized for the purpose of conducting the business of a professional corporation in the area of the psychiatric practice of medicine. The corporation shall have the power to do all things necessary or required to be done in the furtherance of such practice, and all things legally allowed to be done by a professional corporation under the laws of the State of Rhode Island.

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is:


