The undersigned acting as incorporator(s) of a corporation under Chapter 71.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Garbolino, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended.) (Strike if inapplicable.)

2. The period of its duration is (if perpetual, so state) perpetual

3. The specific purpose or purposes for which the corporation is organized are:

To sell, alter, and repair, women's apparel and accessories on a retail and wholesale
basis and to include any other associated activities to support that purpose, and to
transact any other lawful business for which corporations may be incorporated
under the Rhode Island Business Corporation Act and to have all other powers
conferred upon this Corporation by said Act.
