ORIGINAL ARTICLES OF INCORPORATION

FIRST. The name of the corporation is <u>G. DUCHIN & ASSOCIATES INCORPORATED</u>, a close corporation pursuant to §7-1.1-51 of the Rhode Island General Laws, 1956, as amended.

SECOND. The period of its duration is perpetual.

THIRD. The purpose or purposes for which the corporation is organized are:

To manufacture, design, style, produce, process, prepare, merchandise, buy, sell, transport, distribute, export, and import, at wholesale, retail, and as jobber, as principal, contractor, broker, sales representative, or agent on commission, and otherwise generally and in all ways handle, trade, and deal in and with goods, wares and merchandise of every kind and nature.

To acquire by purchase, assignment, grant, license, or otherwise, to apply for, secure, lease, or in any manner obtain, to develop, hold, own, use, exploit, operate, enjoy, and introduce, to sell, assign, lease, create security interest in, pledge, grant licenses and rights of all kinds in respect of, or otherwise dispose of, and generally to deal in and with and turn to account for any or all purposes, either for itself or as nominee or agent for others: any and all inventions, devices, processes, discoveries, and formulas, and improvements and modifications thereof and rights and interests therein; any and all letters patent or applications for letters patent of the United States of America or of any other country, state, locality, or authority, and any and all rights, interests, and privileges connected therewith or incidential or appertaining thereto; any and all copyrights granted by the United States of America or any other country, state, locality, or authority, and any and all rights, interests, and privileges connected therewith or incidental or appertaining thereto, and any and

all trademarks, trade names, trade symbols, labels, designs, and other indications of origin and ownership granted by or recognized under the laws of the United States of America or any other country, state, locality, or authority, and any and all rights, interests, and privileges connected therewith or incidental or appertaining thereto.

To engage in any lawful business, act or activity for which corporations may be incorporated under Title 7, Chapter 1.1 of the Rhode Island General Laws, 1956, as amended.

The corporation shall have all powers set forth in §7-1.1-4 of the Rhode Island General Laws, 1956, as amended.

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is Eight Thousand (8,000) shares common stock, par value, One Dollar (\$1.00) per share.
