AN ACT RELATING TO RIH CARDIOLOGY FOUNDATION, INC.

It is enacted by the General Assembly as follows:

SECTION 1. RIH Cardiology Foundation, Inc., a non-business corporation organized under chapter 7-6 of the general laws, shall be entitled to take, hold, transmit and convey real and personal estate to an amount not exceeding one million (\$1,000,000) dollars.

SECTION 2. This act shall take effect upon passage.

AN ACT AUTHORIZING THE INCREASE OF THE HOLDINGS OF THE MIRIAM HOSPITAL FOUNDATION TO AN AMOUNT NOT EXCEEDING \$1,000,000

It is enacted by the General Assembly as follows:

SECTION 1. The Miriam Hospital Foundation, a non-business corporation organized under the laws of the State of Rhode Island on May 18, 1978, is hereby authorized to receive, take, hold, transmit and convey real and personal property of a total value not to exceed one million dollars (\$1,000,000), so long as said property shall be used for the non-business purposes for which said corporation was incorporated.

SECTION 2. This act shall take effect upon passage.

AN ACT AUTHORIZING C.Y.O. of Northern R.I., Inc. TO INCREASE ITS HOLDINGS TO AN AMOUNT NOT EXCEEDING \$1,500,000

It is enacted by the General Assembly as follows:

SECTION 1. C.Y.O. of Northern R.I., Inc., a non-business corporation, incorporated under the general laws of this state on December 17, 1970, is hereby authorized to take, hold, transmit and convey real, mixed and personal estate to an amount not exceeding one million five hundred thousand dollars (\$1,500,000), so long as said estate shall be used for the purpose for which said corporation was incorporated.

SECTION 2. This act shall take effect upon passage.

AN ACT IN AMENDMENT OF SECTION 1 OF AN ACT PASSED AT THE MAY SESSION OF THE GENERAL ASSEMBLY, 1890, ENTITLED "AN ACT PERMITTING THE EAST GREENWICH FREE LIBRARY ASSOCIATION TO TAKE AND CONVEY REAL AND PERSONAL ESTATE NOT EXCEEDING FIFTY THOUSAND DOLLARS."

It is enacted by the General Assembly as follows:

SECTION 1. Section 1 of an act passed at the May session of the general assembly, 1890, entitled "An Act permitting the East Greenwich Free Library Association to take and convey real and personal estate not exceeding fifty thousand dollars," as amended, is further amended to read as follows:

"SECTION 1. The East Greenwich Free Library Association, a corporation organized in accordance with the provisions of chapter 160 of the public statutes, 1882, is hereby authorized, notwithstanding the provisions of section 6 of said chapter, to take, hold, transmit and convey real and personal estate to pay amount not exceeding two million dollars (\$2,000,000.00), in addition to the fair market value of its buildings, the land upon which the same is situated, and the fair market value of its books, maps, pictures, and library fixtures."

SECTION 2. This act shall take effect upon passage and all acts and parts of acts inconsistent herewith are hereby repealed.

AN ACT TO AUTHORIZE THE AUDUBON SOCIETY TO TAKE, HOLD, TRANSMIT AND CONVEY REAL AND PERSONAL PROPERTY TO A TOTAL VALUE NOT TO EXCEED \$12,000,000.

corporation incorporated on April 26, 1948 under the general laws of this state is hereby authorized to receive, take, hold, transmit, and convey real or personal property to an amount not to exceed five hundred thousand dollars (\$500,000). The real and personal property so received, taken, held, transmitted and conveyed shall be exempt from taxation by any town or city in the state of Rhode Island as long as such property shall be used for the purposes described in the articles of association of said corporation.

AN ACT TO AUTHORIZE C.Y.O. OF NORTHERN RHODE ISLAND, INC. TO RECEIVE, TAKE, HOLD, TRANSMIT, AND CONVEY REAL AND PERSONAL PROPERTY TO AN AMOUNT NOT TO EXCEED ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000)

It is enacted by the General Assembly as follows:

SECTION 1. C.Y.O. of Northern Rhode Island, Inc., a non-business charitable corporation, incorporated under the laws of the state of Rhode Island on December 17, 1970, for the purposes permitted for non-business corporations, is hereby authorized to receive, take, hold, transmit, and convey real and personal property to an amount not to exceed one million five hundred thousand (\$1,500,000) dollars, so long as it shall be used for the purposes for which said corporation has been incorporated.

SECTION 2. This act shall take effect upon passage.

AN ACT AUTHORIZING Cranston Portuguese Club, Inc. TO TAKE, HOLD, TRANSMIT, AND CONVEY REAL AND PERSONAL ESTATE TO AN AMOUNT NOT EXCEEDING FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00)

It is enacted by the General Assembly as follows:

SECTION 1. Cranston Portuguese Club, Inc., incorporated as a non-business corporation under the general laws of this state on February 17, 1932 is hereby authorized to take, hold, transmit, and convey real and personal estate to an
