OTHER PROVISIONS REGARDING THE INTERNAL AFFAIRS OF THE CORPORATION. If any stockholder desires to sell part or all of his shares of stock at any time during his lifetime, he shall first give written notice thereof to other stockholders of the price and other terms proposed by the selling stockholder. Other stockholders, upon receipt of such notice, shall have sixty (60) days to purchase said shares of stock at the price identified in the notice from the selling stockholder. If said shares of stock are not purchased within the aforesaid period, the stockholder desiring to sell said shares may dispose of them in any lawful manner available to him, but not at a price less than that rejected by other stockholders without first offering to sell said shares to other stockholders at such lesser price.
