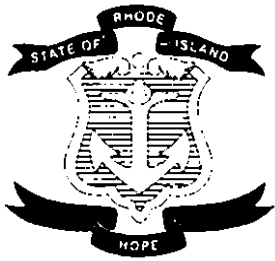

4 certificate signed by the tax administrator that such tax returns and such taxes have been paid; and

6 revocation of the charter of said company shall thereupon to wit, upon the filing of said


