

	federal tax code, or shall be distributed to the State of Rhode Island for a public			
	purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas			
	of the county in which the principal office of the organization is then located,			
	exclusively for religious purposes or to such organization or organizations, as said Court			
	shall determine, which are organized and operated exclusively for religious purposes.
