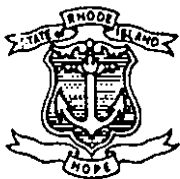

ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Inland Waters, Inc.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

3. The specific purpose or purposes for which the corporation is organized are:

To provide underground pipe rehabilitation services and environmental clean up

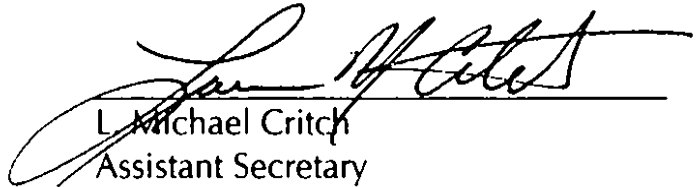


The undersigned, Inland Waters Pollution Control, Inc., a Michigan corporation, has no objection to and consents to the incorporation of Inland Waters, Inc.
