

### **Article 1: Name and Location**

The name of this corporation, which is a nonprofit corporation organized under the Nonprofit Corporation Act of the State of Rhode Island, is Cranston Street Hockey League, Inc.

### **Article 2: Purpose**

1. General Purpose. The Cranston Street Hockey League, Inc. is organized and operated:
  - a) Exclusively as a qualified amateur sports organization within the meaning of ' 501(c)(3) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law, including for such purposes, the making of distributions to organizations which are recognized as exempt from tax under such ' 501(c)(3).
  - b) To exercise such of the rights, powers, duties and authority of a nonprofit corporation organized under the Nonprofit Corporation Act of the State of Rhode Island which are consistent with the preceding paragraph.
2. Specific Purposes. The specific purposes of the Cranston Street Hockey League include, without limitation, are the following:
  - a. Provide a community of children with an organization and facilities that will allow them an equal opportunity to participate in the sport of hockey by organizing leagues, after school programs and tournaments to support and develop children for future amateur hockey competitions.
  - b. Raise funds necessary to provide affordable programs for all children, reduced cost programs for at risk children, free or reduced cost facility usage for other local non-profit youth organizations and schools in the community and raise funds necessary to maintain and improve organization facilities for the safe, supervised participation for children.
  - c. Conduct background and screening processes on all volunteers, national certification programs and training seminars for coaches and game officials, and educational programs for parents in an effort to promote and advance the values of sportsmanship, teamwork, responsibility, respect, and fun in youth sports.

### **Article 3: Dissolution Clause**

Upon the dissolution or winding up of the Cranston Street Hockey League, Inc., or in the event it shall cease to engage in carrying out the purposes and goals set forth in these Articles, all of the business, properties, assets and income of the Cranston Street Hockey League, Inc. remaining after payment, or provision for payment, of all debts and liabilities of this Cranston Street Hockey League, Inc., shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for tax exempt purposes which are reasonably related to the purposes and goals of this Cranston Street Hockey League, Inc., as may be determined by the Board of Directors of this Cranston Street Hockey League, Inc. in its sole discretion, and which has established its tax exempt status under ' 501(c)(3) of the Internal Revenue Code of 1986, as amended.
