ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is OCEAN STATE ARTISANS

SECOND: The period of its duration (if perpetual, so state) PERPETUAL

THIRD: The purpose or purposes for which the corporation is organized are: TO PROVIDE A WORKING OPPORTUNITY FOR R.I. ARTISANS TO RAISE THE ARTISTIC CONSCIENCE OF THE PEOPLE OF R.I. THROUGH EDUCATIONAL ACTIVITIES, PROVIDE ITS MEMBERS WITH A BROAD BASED SUPPORT SYSTEM AND RECOGNITION, AND TO ENHANCE ORIGINALITY AND EXCELLENCE.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are: AFTER PAYMENT OF ALL (Note 1) DEBTS, THE ASSETS SHALL BE CONVERTED TO A SCHOLARSHIP FOR ART STUDENTS.
