In the event that any Stockholder, or the heirs, administrators, executors, successors or assigns of any Stockholder, or any person to whom title of any Stockholder in stock of the Corporation may pass or devolve by assignment for the benefit of creditors, appointment of a receiver, filing of a petition in bankruptcy, or by operation of law or otherwise, shall desire to sell the whole or any portion of his/her stock in the Corporation, he/she shall, before offering the same for sale to any other party, give notice in writing to the Corporation of his/her desire to sell, and in such writing offer to sell the same to the Corporation at the lowest price at which he/she is willing to sell said stock. Within twenty (20) days of the date of such notice, the Board of Directors or an Officer of the Corporation designated by the Board of Directors, shall deliver to such Stockholder, personally, or by registered mail, return receipt requested, addressed as stated on the books of the Corporation, a notice, in writing, signed by the Board of Directors or the designated Officer, of the election by the Corporation to purchase such stock. If such notice of election to purchase shall not be given within twenty (20) days, the stockholder shall be at liberty to sell said stock to any other party, provided that such sale is made within fifteen (I5) days after the expiration of the said twenty (20) days, and at a price not less than the price at which it was offered to the Corporation.

The Directors may in a particular instance consent to any such proposed sale, but no such consent or waiver shall extend to other or subsequent instances.

6. Provisions (if any) for the regulation of the internal affairs of the corporation:

The capital stock of the corporation, without par value, may be issued from time to time for such consideration consisting of cash, services, personal property, tangible or intangible or real estate as may be determined from time to time by the Board of Directors.
