(c) to have and use a common seal and after the same at pleasure; (d) to elect such officers and appoint such agents as its purposes require, and to fix their compensation and define their			
(e) to make hy-laws not inconsistent with the constitution or law of the Helind Course of the			
corporation's charter or articles of association, determining the time and place of holding and the manner of calling and of conducting meetings of its members and directors, the manner of electing its officers and directors, the mode of voting by proxy, and the number, qualifications, powers, duties and term of office of its officers and directors, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs;
