- 1. That on the 8th day of February, 1972, the Board of Directors of the Greenwood Credit Union, by a unanimous vote of those present, approved the proposed merger of the Greenwood Credit Union with the Sealol Employees' Credit Union. The plan of merger was to be proposed to the Shareholders at a meeting called for on the 7th day of March 1972.
- 2. That on the 7th day of March, 1972, the Shareholders of the Greenwood Credit Union, at a special meeting held at its auditorium, 764 Main Avenue, Warwick, Rhode Island, voted to accept the transfer of the assets and assume the liabilities of the Scalol Employees' Credit Union.
- 3.
