- It is required by law to provide a street address in Item 3 of the preceding form in order to provide the public with notice of a physical location at which process, notice or demand required or permitted by faw may be served on the registered agent. A Statement of Change of Registered Agent submitted with a post office box address only will not be accepted for filling.
- The effective date of the Statement of Change of Registered Agent shall be the date of filing with the Secretary of State or upon such later date not more than thirty (30) days after such filing, as may be set forth in item 6 of the statement.
- 4. The Statement of Change of Registered Agent must be signed on behalf of the corporation by an authorized officer.
- The fee for filling the Statement of Change of Registered Agent by the Corporation is \$20.00, and payment should be made payable to the Rhode Island Secretary of State.
